This solid commitment has significantly reduced such crimes by over 80%, reflecting the SIU's efficacy in upholding human rights.

For the importance of providing accurate statistics and reports, and as a confirmation of the unit's commitment to transparency, it presents its third annual report. This report includes a comprehensive and detailed overview of all the work carried out by the Special Investigation Unit during the year 2023.



First: Total Complaints Received by the Unit




Second: Classification of Complaints

Third: Nationalities of Complainants







Sixth: Complaints by Month




Seventh: Comparison of the Total Complaints Received by the Unit During the Year with Previous Years





Second: Accused and Suspects Interviewed





Fourth: Disciplinary sanctions issued by the Military Courts Administration at the Ministry of Interior

SIU received disciplinary sanctions issued by the Military Courts Department at the Ministry of Interior in three different cases against four members of the Public Security Forces. SIU had previously ordered their referral to the Military Courts Administration to impose an appropriate disciplinary sanction on them. The disciplinary sanctions were as follows:

Part Four: Training Programs and Activities During The Year

First: Conferences, Seminars, and Training Programmes

The "National Training Programme to Enhance the Capacities of Those Concerned with the Protection of Human Rights in the Criminal Justice System," initiated in October 2022 under the esteemed patronage of His Excellency the Attorney General, Dr. Ali bin Fadhul Al Buainain, has concluded its activities. The programme, jointly organized by SIU and the UNDP, The Royal Academy of Police, and the Judicial and Legal Studies Institute, encompassed **9** events focusing on three main topics.



The programme attracted a total of **891** participants, comprising officials, members of national institutions, mechanisms, and agencies dedicated to human rights protection, law enforcement authorities, and civil society organizations. It addressed **50** diverse topics featuring presentations by a distinguished panel of national and international experts, with Bahraini experts representing over **80%** of the speakers. Additionally, female speakers accounted for **30%** of the total presenters.

July 17: The Special Investigation Unit delivered a lecture titled "Establishment of the Special Investigation Unit and Its Jurisdictions" as part of the training program organized by the Legal Affairs Directorate at the Ministry of Interior for its members.

October 18-19: The Deputy Head of SIU contributed a working paper at the conference organized by the Ombudsman Office commemorating its 10th anniversary. The paper, titled "The Effectiveness of Ombudsmen in Institutional Work and Their Role in Promoting Respect for Human Rights".





November 13-14: SIU, in collaboration with UNDP and the Ministry of Foreign Affairs, convened a workshop titled "International Human Rights Procedures and Mechanisms" The workshop featured the participation of numerous international experts, representatives and associates of relevant national agencies and organizations, as well as civil society organization.



November 21: SIU, in collaboration with the General Secretariat of the Shura Council, convened an introductory seminar interpreting the roles and specializations of SIU, along with the international standards upheld in its operations.





December 11: The Head of SIU participated in an open dialogue symposium organized by the Ombudsman Office to coincide with International Human Rights Day and the 75th anniversary of the adoption of the Universal Declaration. The symposium, titled "Promoting Respect for Human Rights: Duties and Challenges," provided a platform for discussions on pertinent human rights issues.



December 13: In collaboration with the General Secretariat of the House of Representatives, the head of SIU delivered a lecture on the establishment of SIU, its competencies, and its implementation of the principles outlined in the Istanbul Protocol.

Second: Launching SIU's Website

February 27: In alignment with the digital transformation and technological advancement strategy, and to uphold the principle of transparency that SIU has embraced since its inception, a modest ceremony was held in the presence of His Excellency the Attorney General, Dr. Ali bin Fadhul Al Buainain, and His Excellency Mr. Firas Gharaibeh, Resident Representative of the UNDP. During this event, SIU officially unveiled its website, providing a platform for submitting complaints and accessing all periodic and annual news, as well as reports issued by SIU.
